- Vehicle must not have been totaled, stolen, exported from the US, imported to the US from another country or have branded
- The Audi CPO Limited Warranty is only eligible to be transferred from private owner to private owner and must be requested by the original purchaser of the CPO vehicle. **Dealership participation is excluded**.
- Transfer application must be submitted by the original Certified pre-owned owner within 30 days of vehicle sale.
